ATHLETIC DIRECTOR REPORT

Chris Wehner, Athletic Director, gave his report to the board. He explained the number of students that are out for sports. There is still a small number, but he hopes to see that number rising in the future. He is planning on a football camp and a basketball camp this summer. Some changes to the sports complex need to happen. The bleachers that were purchased for the new building need to be moved to the other side of the field and the old bleachers brought over from the old site. He would like to move the crow's nest over to be moved over as well.

SUPERINTENDENT REPORT

BJ Buchmann gave his report to the board. He started with recognizing the DAAC and all that they have been working on. He spoke about the Parent Teacher Conferences that will be Wednesday and Thursday of this week. He spoke of the assessments that were given this last month.
