MOTION: Wesley Thompson made the motion to approve the Agenda with the additions of 6.2A Approval of Resignations-Rebecca Coffee and Sarah McFarland, 6.2B Resolution for Non-Renewal, 6.5 New Hire and delete 7.0 Executive Session. "WHEREAS, Colorado Revised Statute section 22-31-129(1)(h) provides that a vacancy occurs in a school director office whenever a person who was duly elected or appointed does not attend three consecutive regular meetings of the board of education; and WHEREAS, Christel McNeil did not attend the board of education's regular meetings on January 11, 2021, February 8, 2021 and March 8,2021; Be it resolved that, in accordance with state law, the Board declares a vacancy in this school director office; Be it further resolved that, in accordance with state law, the Board will fill the vacancy by appointment within 60 days in accordance with the following procedure; 1. Interested persons are invited to send a letter to the Board with a statement of interest qualifications by May 5, 2021. 2. The Board will interview prospective candidates on May 10, 2021 at a public meeting. 3. To be eligible for appointment, a candidate must be a registered elector of the Deer Trail School District26J. 4. The appointee will serve until the next regular school biennial election in November 2021 at which time an election will be held for a successor to fill the remainder of the unexpired term.
