Board President Mike Geesen called the meeting to order at 7:05 PM. Reagan Hahn and Candice Reed were absent. Also in attendance: BJ Buchmann, Nanci Sweet, Hayley Whitehead, Seandra Humbert and Mike Jobman.

MOTION: Mike Cowell made the motion to approve the Agenda with the change of removing Policy JJJ-R off of the Consent Agenda down to 7.2.A. Wesley Thompson seconded the motion. Cowell, aye; Geesen, aye; Thompson, aye. Motion carried

#### SUPERINTENDENT REPORT

Mr. Buchmann had many things to speak about. He thanked Cindy Schindler the school nurse for always staying so calm in dealing with the situations that arise at the school. Hayley Whitehead thanked Mike Jobman for his hard work on the schedule and getting the games rescheduled that had to be postponed. Mike Geesen thanked the staff again for working hard through these crazy times. Mr. Buchmann let the majority of the time go to Seandra Humbert who went over i-Ready testing results from August.

#### PRINCIPAL REPORT

Mr. Jobman spoke about the games being rescheduled, the camera that was put in the gym and working on the camera for the football field. He mentioned the middle school movie night and how well the auditorium worked for that. He explained that the lights in the locker rooms are being changed out for the key lights to keep the kids from turning the lights off on one another. He spoke about Math and how that was working.

#### DISCUSSION

##### Construction Fund

Mike Cowell brought up that he didn't want to be the only one knowing where the money went from the construction fund. He would prefer that if there is something that needed to be purchased, that it be purchased. At the next meeting, the Board can decide if that purchase should come out of the Construction Fund.

##### Board Member Appointments

Since the election had to be canceled for lack of verifiable petitions, Hayley Whitehead explained that AFTER the one board member was sworn in at the November Meeting, the new Board would then ask for letters of interest to be sent in. At the December meeting, those people could be interviewed and either placed on the board or wait for more letters. It will be the decision of the new Board.

There was discussion about Policy JJJ-R. The changes to it were made by the Principal and the Superintendent. The process will now be that the Eligibility Report will be pulled at 11:00 on Monday. The Principal/AD will speak to the kids about their grades. Parents will be notified. If, by Thursday at 11:00, the student's grades are still at the ineligible level when the report is pulled again, the student is immediately ineligible for the activities until the following Monday.

MOTION: Mike Cowell made the motion to approve the purchase of the 14-passenger bus from Collins if Sam Courts could get the paint changed to yellow, the lights and the stop sign put on it for \$70,000 or less.
