BJ Buchmann gave his report. He recognized the FFA and the week of events that took place. He thanked the basketball teams, coaches, and parents for a great season. Thank you to Colorado PDQ C-Store for a donation of an air compressor that can be auctioned off or sold outright, with proceeds going to the Deer Trail FFA. The Nutritional Services did a great job with their audit and are in full compliance. The School Nurse is managing and tracking student immunizations and we are at about 87% compliance at this date. He explained that the Arapahoe County Sheriff's Office SROs will either be at Byers or Deer Trail Schools during spring break doing some training. The district took training on Friday for CMASS testing which will start March 29 for secondary science. The FFA bids are in and Dryland Electrical and IREA will handle the electric. Colorado Natural Gas will be coming to DT this week and Cody Stombaugh will handle the Gas. Hamacher's Water is pending installation after the Spring break. Math, ELL/Spanish, Student Data/Computer Coordinator positions are posted. Volleyball practice started today. We are working on the budget with budget reviews. We have met with the home inspector and have that information put in binders. HWP-1 motor is delayed because it came damaged.

BE IT FURTHER RESOLVED, the use of this portion of the beginning fund balance for the purpose set for above will not lead to a deficit." Candice Reed seconded the motion.
