Principal/AD Report

i-Ready testing resulted in some pretty good results. The SAT scores came and they were a mixed bag of results. The pole was set for the Pixalot camera for the football field. There are interviews going on. Summer basketball is going well this year. They have a tournament this last weekend went 3-3. It was a great experience for the boys. 35 plus boys showed up for the meeting with Coach Simmons. The Rodeo is in July and will be a successful concession experience. The sports kids will have floats in the rodeo parade.

DISCUSSION ITEMS

Dress Code-The discussion was started off with Candice Reed saying that the clothing worn at the 8th Grade Continuation was in violation of dress code. Mike Cowell went on to say that the clothing worn at the Award's Night was not good either.

Basically it was decided that no hats and sunglasses should be worn. There should be no slits, hems, holes above finger tip length. Hems need to be fingertip length with arms relaxed standing straight up. No midriff shirts. If there is a violation, it should be documented. Clothing needs to be changed before kids are let back to class. Coaches need to be upholding the dress code with the players. The part about no open toed shoes needs to be taken out of dress code in the hand book.

BJ Buchmann explained that the school always signs the agreements for ECBOCES for the Consolidated Application for ESEA Program Funds, the BOCES Assignment Agreement, the School Improvement Retention of Funds Request Form and the District Assurances for the Consolidated Application.

Nanci Sweet wanted it to be documented that she was moving money from the General Fund to the Activity Fund for athletics-\$5,000.00. She was moving \$73,800 from the Lunch Fund to the General Fund to keep the lunch fun below \$17,000. She was also moving \$50,000 from Colorado Trust to the Capital Reserve Fund. The Balance of the Capital Reserve Fund is currently \$68,052.69.
