SUPERINTENDENT REPORT

Mike Jobman had Seandra Humbert introduce all the new staff that had attended the meeting. Mike thanked Seandra and Krista for working so hard on scheduling for the students and getting things straightened out. The freezer is down again. It should be fixed by the end of today. Drainage is also fixed. Kyle Dasenbrock is taking over Student Council. Homecoming is October 9. There is a CPR First Aide class on Friday during in-service. The enrollment is at 356. Still need a Para. The NFHS Picalot camera was broken. The score board wasn't working. The camera has been fixed. Mike fixed the score board. CHSAA had put out heat warnings for practices. We need help with concessions if people want to help, it would be greatly appreciated. Back to School Night had a large turnout. We will do it in two nights next year. Vape Sensors are working. There is a Rockies game coming up on September 26. Mike had attended the Superintendent Conference. They were talking about the start of the year, funding, and all of the Special Education students that needed to be transported to different facilities. We have our safety plan done.

ELEMENTARY PRINCIPAL

Seandra Humbert explained that there will be 182 elementary students. The teachers received grant money from Donor's Chose, a CDE grant in which teachers received approved supplies for their classrooms. She will be doing the UIP training, attending the Principal's Cluster. PTO kicked off. The PTO will be having a book fair in October.

ELECTION UPDATE
